# **Report from Borough Councillor Mick Burgess**

The planning department was tied up working on applications affected by Stodmarsh Wetland phosphate and nitrate contamination and so the January Planning Committee meeting had been cancelled. Funding withdrawal was closing down Action with Communities in Rural England and new homes were being sought for the various schemes it ran.

# **Public Questions 7.35pm**

#### **Appledore Local History Society**

Members highlighted that the request for funding was not a building but rather a 'structure' to house not only their archives but also their regular activities such as exhibitions and meetings, plus a venue to allow members of the public to search the records.

#### Over 60's Xmas lunch

The lunch had not been run by the village hall but by two trustees in their own capacity as residents.

# 3. Planning

# **3.1 Planning Decisions by Ashford Borough Council** None.

#### 3.2 Planning Applications Considered

- I) PA/2022/3006 Park House, Tenterden: Proposed replacement two storey outbuilding including annex and solar panels to north elevation. It was resolved to support. Proposed by Councillor Winter and seconded by Councillor Davis.
- II) PA/2022/3049 2 Maple Court, Court Lodge Road: Proposed installation of solar panels on roof of dwelling. It was resolved to support. Proposed by Councillor Thornton and seconded by Councillor Davis.
- III) PA/2022/3081 Apple Tree Court, Woodchurch Road: Change of use of residential outbuilding studio loft space to a one bed holiday let (retrospective). It was resolved to support. Proposed by Councillor Winter and seconded by Councillor Kinsley.

# 4. History Society Funding Request for a Building ('Structure') on the Recreation Ground to House Archives (and the Society's Regular Activities)

The council noted that both the Parish Council and the Recreation Ground Committee had ownership rights to the area between the public toilets and the sports pavilion which was being proposed as a location for the History Society's structure. Therefore, the council suggested that the History Society contact the Recreation Ground Committee out of courtesy. The council pointed out that the Recreation Ground Committee was already pushing ahead with the linear park (approved as part of the village hall refurbishment planning application) and hired a gardener. The garden area proposed in the plans for that same spot, would also include a war memorial along the lines of the one in New Romney. The council was also aware that discussion for the redevelopment of the sport pavilion included an extension for the History Society.

The parish council requested the group to speak with the Recreation Ground Committee and to reapproach the council with a fleshed-out scheme of costings and an indication of how the project might be financed.

#### 5. Highways and Byways

The completion of repairs to the pavement opposite Miss Mollets is scheduled to restart on the 12<sup>th</sup> January.

Clerk was asked to chase the painting of the road markings to complete the new Gateways.

The Chairman has received a further comment about the deep undulations along the road between the canal bridge and the Station.

The National Trust has now replaced the rotten fence above the ditch near to the footpath entrance of The Royal Military Canal.

# 6. Community Engagement

#### **6.1 Resilience Planning**

There had been a positive response from volunteers willing to offer help, together with names of those requiring support. A piece in the February Parish Magazine will remind all that there is still time to drop the completed survey into the shop. Councillors Thornton and Lusk will be in touch with those who had responded.

#### 6.2 Speed watch

Roadside training for this had been rescheduled, due to weather again, to the 13<sup>th</sup> January.

#### 6.3 Litter

In order to keep costs down, it was suggested that the council made use of the free loan of an antilittering banner from Ashford Borough Council and install it on the recreation ground fence as a trial. As previously stated, all banner locations had to be approved by Ashford Borough Council. There was also an option to insert a smaller poster version on the sleeve of public bins which would be taken up too. Terry Blaney was thanked for all the ground work he had already done.
